Such a gift will assist the Foundation in its mission to support outstanding Australians with the education, international networks and confidence to tackle the complex challenges facing our nation.



## How your bequest will make a difference

Leaving a gift in your Will is a powerful way to celebrate your life's passions and have an enduring impact on the future of Australia. Your gift will honour your memory and provide a legacy of hope for generations to come.

It is your decision whether your gift is directed to a specific purpose or without a defined intention. You can choose where your gift belongs. A general bequest to the Foundation can be left to support the work of the Foundation, including scholarships and the Alumni Community.

### **An open Gift to the Foundation:**

Provides us with the flexibility to dedicate the funds to scholarship stipends.

### **Support the Scholar Alumni Community:**

To build their connectivity and promote their endeavours through a range of programs and initiatives, including the Global Symposia, leadership and professional development programs.

### **Establish a John Monash scholarship in your name or the name of someone you celebrate:**

This can be for any number of specified scholarship years and provide a one, two or three year award for the successful candidate. Each scholarship year requires a donation of \$90,000\*.

### **Establish a perpetual, named John Monash Scholarship:**

A substantial bequest to the scholarship endowment will ensure you always have a Scholar in the field carrying your chosen name.

## How to include a gift in your Will

Advising us of your decision to make a gift to the General Sir John Monash Foundation in your Will assists us in planning for the future and provides us with an opportunity to discuss with you how you would like to support used.

There are different types of gifts you can leave in your Will to the General Sir John Monash Foundation.

### **A residuary gift:**

Made from the balance remaining from your estate once gifts of money and specific items have been distributed.

You can give the whole of the residue to the General Sir John Monash Foundation, or a portion of it.

### **A pecuniary gift:**

A specified sum of money from your estate.

### **A specified gift:**

Involves leaving a particular item of value to the Foundation, such as a residential property, company shares or artwork.

If you are considering leaving a non-monetary gift to the Foundation, we ask that you contact us to ensure the Foundation is able to accept the gift and honour your wishes for it.

## Legal wording for your Will

We recommend that you consult an independent solicitor or accredited Wills and Estates specialist to ensure your wishes are recorded correctly. If you do not have a solicitor, Law Societies in every state or territory publish lists of accredited specialists in Wills and Estates. If you wish to change your Will, we encourage you to talk to your legal representative.

You can either add a clause to your Will pertaining to your gift or add a codicil – short legal amendment – to an existing Will. Examples for your legal advisor are indicative of language and important information to include.

### Residuary wording for gift of whole or part of estate:

*I give (the whole of my residuary estate/x of y parts of my residuary estate) to the General Sir John Monash Foundation ABN 78 099 065 184 ("Foundation") currently of Bennelong House, 9 Queen Street Melbourne Victoria 3000, to be used for the general purposes of the Foundation. I declare that the receipt of the Company Secretary or other Authorised Representative of the Foundation shall be a complete discharge to my executors or trustees.*

### Specific legacy clause:

*I give the sum of \$, free of all duties and taxes, to the General Sir John Monash Foundation ABN 78 099 065 184 ("Foundation") currently of Bennelong House, 9 Queen Street Melbourne Victoria 3000 to be used for the general purposes of the Foundation. I declare that the receipt of the Company Secretary or other Authorised Representative of the Foundation shall be a complete discharge to my executors or trustees.*
