#### **Dr Katherine Rock**

2004 John Monash Scholar Former Head of Patents, Xero

Katherine is a registered patent attorney in Australia and New Zealand and the former Head of Patents at Xero. She is a Fellow of the Institute of Patent and Trademark Attorneys of Australia and serves on professional committees, including the ChIPs ANZ chapter leadership. She earned a DPhil in Engineering Science from Oxford, an MBA with distinction from Cambridge, and a Master of Intellectual Property from UTS. Katherine was the top graduate in her Engineering and IT degrees at Griffith University and is currently pursuing a Master of Economics at the University of Queensland.



**Dr Tim Trudgian**2006 John Monash Scholar *Professor, UNSW Canberra* 

Tim obtained a DPhil in mathematics from Oxford in 2010. He returned to Canberra in 2012, after a two-year post-doc in Canada, as an ARC Early Career Research Fellow at ANU then an ARC Future Fellow at UNSW Canberra at the Australian Defence Force Academy. His research is analytic number theory. His two sons are named after former Australian Test cricketers and have both developed the full Trudgian-esque armoury of offside shots.



**Dr Alice Chang** 

2008 John Monash Scholar Psychiatrist, Edgehill Clinic

Alice earned her Master's Degree in Public Health from Cambridge University in 2009, focusing on rural health issues, especially chronic diseases in rural Australia. Her dedication to youth health began early, recognised as Young Queenslander of the Year in 2003, and as a Young Australian of the Year finalist in 2004 and 2006. Alice is a Child and Adolescent Psychiatrist in Cairns, committed to the wellbeing of Indigenous youth in regional areas. She specialises in infant mental health and is pioneering the first infant mental health service in Far North Queensland. Alice is a Fellow of the Royal Australian and New Zealand College of Psychiatrists, coordinates a rural eye health program, and is an Associate Lecturer at the University of Queensland and James Cook University.



**Dr Tim O'Shea**2009 John Monash Scholar *Assistant Professor, Boston University* 

Tim is an Assistant Professor of Biomedical Engineering at Boston University and leads the Glia Engineering Lab. He earned his Bachelor's Degree in Medical Engineering and Master's Degree in Engineering Management from QUT. Awarded a John Monash Scholarship in 2009, Tim pursued a PhD in Medical Engineering and Medical Physics through the Harvard-MIT Health Sciences and Technology program. Under Professor Robert Langer, his PhD research developed injectable biomaterials for spinal cord injury therapies, earning several awards. Post-PhD, Tim held a postdoctoral fellowship at UCLA, focusing on glial cell roles in injury and foreign body responses. His work has been published in prestigious journals such as Nature and Advanced Materials.



**Dr Katie Quinn** 

2009 John Monash Scholar Associate Director of Bioinformatics, Guardant Health

Katie is a Postdoctoral Research Scientist in Biomedical Informatics at Stanford University. She specialises in utilising emerging electronic health data to enhance patient outcomes, with a current focus on analysing health impacts of multi-drug treatments through large insurance claims databases. Katie completed her PhD at MIT, where her research involved quantitative modeling to explore gene expression dynamics.



#### **Dr Joe Gattas**

2010 John Monash Scholar Associate Professor at the University of Queensland's School of Civil Engineering

Joe is an Origami Engineer and Senior Lecturer at the University of Queensland, where he leads the Folded Structures Lab, which he founded in 2014. With a Doctor of Philosophy from the University of Oxford, Joe's research focuses on applying origami techniques to create and enhance thin-walled structures. His lab, supported by \$1.2 million in grants, includes six PhD candidates and 15 undergraduate/master's students. They explore efficient applications of folded materials in modular housing, packaging, and automotive and aircraft components. Additionally, Joe contributes to the Australian Research Council Future Timber Hub, advancing digital design and manufacturing for tall timber buildings.



## **Professor Jodi Gardener**

2011 John Monash Scholar Brian Coote Chair in Private Law, the University of Auckland

Jodi holds the Brian Coote Chair in Private Law at the University of Auckland. She earned her Bachelor of Laws and Bachelor of International Relations from Griffith University and completed a DPhil in Consumer Protection at Oxford as a John Monash Scholar. Before academia, Jodi practised as a solicitor specialising in consumer protection. She has held prestigious roles at the University of Cambridge, Columbia Law School, and the Max Planck Institute for Comparative and International Private Law. She is a Senior Research Fellow at the National University of Singapore. Jodi's research focuses on creating fair lending policies and regulatory responses to irresponsible lending, and integrating social policy with banking and finance law.



#### **Dr David Smerdon**

**2011 John Monash Scholar** Senior Lecturer, School of Economics, University of Queensland

David is a researcher with a passion for applied economics, behavioural science and policy solutions. His work spans academic disciplines and often focuses on wicked problems, such as cheating and dishonesty, gender inequality, and policy challenges in developing countries such as female genital cutting and refugee integration. David is skilled in multiple analytic tools including lab and field experiments, big data analysis, applied econometrics and machine-learning. His broad research portfolio has built experience in working in developing countries and collaborating with governments, industry and NGOs across a range of topics. Outside of his work, David is a chess grandmaster and is Australia's highes-ranked player in rapid chess.



## Jessica Denniss

2013 Australian Universities' John Monash Scholar Linguist, University of Toronto

Jessica has a Bachelor of Fine Arts and a Master of Arts in Linguistics and has worked as a linguist then senior linguist in Port Hedland. During this time she worked with the Yinhawangka people to record and document their critically endangered language, spoken today by only a handful of people. She has played a leadership role in her region and her discipline, and her work addresses the loss of indigenous linguistic diversity in Australia (only 20 of 250 languages are still being passed on to children).



May Samali

2014 NSW Premier's John Monash Scholar Founder, Human Leadership Lab

May is the founder and CEO of Human Leadership Lab, a global company specialising in leadership development. With roles as a coach, facilitator, researcher, speaker and investor, she helps unlock leadership potential in organisations and individuals. Previously May was CEO of Ventures at High Resolves Group, leading global teams and technology ventures. She was also the first employee at the Urban Innovation Fund in Silicon Valley and has experience as a lawyer in Sydney. May holds certifications as a Co-Active Coach and Professional Certified Coach, and is a Fellow at Harvard Medical School's Institute of Coaching. She earned a Master in Public Policy from Harvard and first-class degrees in Law and Economics from the University of Sydney. Her work has been featured in publications such as Forbes and the Stanford Social Innovation Review.



## **Catherine Drummond**

2014 Chairman's Circle John Monash Scholar International lawyer

Catherine is an international lawyer dedicated to using international law to uphold critical rights and values. She represents clients before prominent international courts, including the International Court of Justice, the European Court of Human Rights, and the International Criminal Court, as well as international arbitration tribunals. Catherine teaches public international law at the University of Cambridge and is a former Australian high jump champion, nominated for Australian of the Year in 2012. She holds an LLM in Public International Law from Cambridge, where she was the Whewell Scholar, and a dual Bachelor of Laws/Arts from the University of Queensland. Admitted as a Barrister in England and Wales, she is pursuing a PhD at Cambridge, focusing on breaches of international law.



## **Dr Dylan Morris**

2015 Zelman Cowen John Monash Scholar Vascular Surgery Research Registrar

Dylan holds an MBBS (Hons) from James Cook University and a Graduate Diploma in Applied Anatomy and Dissection. He developed a strong interest in cardiovascular research and clinical trials at the Queensland Research Centre for Peripheral Vascular Disease, where he has published nine papers, including a first-author publication in Heart. Dylan served as Editor-in-Chief of the Australian Medical Student Journal and co-founded the James Cook University Surgical Interest Group. After completing his medical internship at Townsville Hospital in 2015, he moved to the UK to pursue a DPhil at Oxford's Clinical Trial Service Unit. His research focuses on using big data to understand carotid artery disease and its link to stroke, and he contributes to the Asymptomatic Carotid Surgery Trial-2 and a meta-analysis of clinical trials on asymptomatic carotid disease management.



#### **Stephen Dietz**

2016 Susan and Isaac Wakil Foundation John Monash Scholar Director, FTA Services Branch, DFAT

Stephen holds degrees in law and international business from Bond University, a Master of International Affairs from the ANU and a Master of Laws from Columbia Law School, Heis a career diplomat and serves as Director in the Department of Foreign Affairs and Trade's FTA Services Branch. Since joining DFAT in 2009, he has served as a trade negotiator and international lawyer in Canberra, London, Geneva and New York. Stephen has also held appointments as Associate to the Hon Justice John Dowsett AM QC at the Federal Court of Australia, Congressional Fellow to US Senator Bob Casey and visiting fellowships at Georgetown University Law Center and Columbia Law School, His studies at Columbia were supported by the Susan & Isaac Wakil Foundation John Monash Scholarship and focused on how the fourth industrial revolution and state capitalism are reshaping the global trade and investment landscape.

Abigael graduated with First Class Honours in a combined Bachelor of Laws/Arts from the University of Queensland. During her studies, she contributed to a project for the European Court of Human Rights, presented internationally on financial sanctions and human rights, and was part of the Australian team that won the Philip C. Jessup International Law Moot World Championship. She also volunteered as a tutor for high school students from refugee backgrounds. Post-graduation, Abigael worked with the United Nations Office on Drugs and Crime in Tehran during the lifting of economic sanctions. As a John Monash Scholar, she completed her LLM at Columbia Law School, where she was named a James Kent Scholar, specialising in anti-corruption and international investment law. Abigael has practiced as an Associate at White & Case in investment treaty arbitration, assisted Amal Clooney's legal team with human rights advocacy, and currently works for the United Nations.



Dr Maja Arsic

Maja has a Bachelor of Science with First Class Honours and the University Medal from Griffith University. She works in the Department of Agriculture and Water Resources and volunteers in alpine vegetation research. She helped found the online magazine North. Maja's research into plants will contribute to development of new crop varieties to address food security. #### **Dr Damon Binder**

Damon is a senior research scholar at the Future of Humanity Institute, which is part of the University of Oxford. He studies questions pertaining to the long-term future of humanity, and, in particular, existential threats to humanity. These are catastrophic events that could cause human extinction, such as the malicious or accidental misuse of advanced artificial intelligence systems or the development and use of nuclear and biological weapons. He hopes to better understand these threats in order to help mitigate them. Damon has a PhD in theoretical physics from Princeton University, where he studied highly symmetric quantum field theories and quantum gravity, and a Bachelor of Science from the Australian National University. When not researching, he enjoys running, cooking, reading history books and making historical recipes.

Brett is a chemical engineer specialising in clean energy and decarbonisation technologies. As Senior Manager of R&D at C-Zero, a clean-tech company in California, he is pioneering technology that converts natural gas into hydrogen without CO2 emissions by extracting hydrogen and leaving behind solid carbon, which can be permanently sequestered. This innovative process leverages existing natural gas infrastructure while providing clean, low-cost energy. Brett gained industry experience in Australia with Incited Pivot, Momentive Specialty Chemicals, and the Dow Centre for Sustainable Engineering Innovations. He completed his PhD at Imperial College London as a Woodside John Monash Scholar. Joining C-Zero in 2020 as an early team member, Brett has been integral to the company's growth, focusing on addressing critical engineering challenges related to climate change and sustainability.

2022 Lee Liberman John Monash Scholar Research Fellow, ISD (Institute for Strategic Dialogue)



2023 John and Anna Belfer John Monash Scholar Psychiatrist, Edgehill Clinic


After moving from Fiji in 2001, Praneel completed a medical degree at Griffith University, graduating with the University Medal. He is completing his specialist training as an obstetrician. A defining professional experience occurred in 2022 when he delivered a stillborn baby from an unwell Indigenous mother from rural NSW. He is troubled by the statistic that a woman dies every two minutes due to largely preventable pregnancy complications. Praneel has undertaken numerous placements focusing on the health of mothers-tobe and babies in rural and remote areas, including in Papua New Guinea and the Northern Territory. "My goal is to lead change to improve maternal health outcomes in disadvantaged communities in Australia and our region."

Among a portfolio of achievements, Dinesh is a doctor for the Gold Coast Titans physical disability rugby team, was a senior adviser to the Disability Royal Commission and is a co-founder of Doctors with Disabilities Australia. Dinesh was Gold Coast Health's Junior Doctor of the Year in 2018, received the Medal of the Order of Australia in 2019, was the 2021 Griffith University Young Alumnus of the Year and Queensland Australian of the Year for 2021. His autobiography, Stronger, was published in 2022. "It was never my intention to become a doctor to earn a salary, but rather to give back to the community. As I build my career, I hope to gather resources to give more and more time freely to Australian communities that need it the most."
