Currently based in Perth, Kirsty is a Technical Specialists Team Lead with sustainable development consultancy Arup and was previously a senior consultant with global engineering consultancy Wood. She completed her Scholarship-supported PhD in Engineering at the University of Cambridge where she worked on the SPICE Project (Stratospheric Particle Injection for Climate Engineering) investigating the benefits, risks, costs and feasibility of solar-radiation management through the deployment of reflective aerosol particles into the earth's atmosphere.

Her study focused on tobacco control issues in indigenous communities, including those of Australia, British Colombia, and New Zealand. She completed an internship at Prime Minister and Cabinet in 2016 and works in indigenous health.

Anna is the Founder and CEO of Homemade Cooking Inc., an online cooking & mindset program focused on healthy lifestyle changes. Previously, Anna was a commercial lawyer at Clayton Utz and Corrs Chambers Westgarth. She acted as a pro-bono lawyer and primary legal advisor for the Australian Employment Covenant and was awarded Australian Young Lawyer of the Year in 2008. After her Scholarship program at Standford University, she was inspired to develop a healthy eating and lifestyle program to help people reduce their risk of illness. 


**Tom Williams**
